
Sir/Madam,






I am directed to refer you on the subject cited above and to say that Hon'ble the Acting Chief Justice and Judges have been pleased to delegate the powers to the District & Sessions Judges in the States of Punjab, Haryana and U.T., Chandigarh to grant special casual leave in lieu of joining time to the officers up to the rank of Additional District & Sessions Judges, transferred in public interest and not at their own request, within a period of three months only after date of relinquishment of charge strictly in accordance with the policy of this Court contained in letter no. 24012 dated 22.09.1978 (copy enclosed) and subsequent instructions thereto and the relevant rules on the point as contained in Civil Services Rules as well as the instructions issued by the respective Governments on the point from time to time. However, the matter relating to joining time of the District and Sessions Judges shall continue to be dealt with by this Court.



The matter regarding the grant of special casual leave equal to the period of joining time admissible under the rules, was considered by the Hon'ble Chief Justice and Judges, and their Lordships have been pleased to order that the special casual leave equal to the period of joining time may be granted as admissible under the rules, but is not availed of by those officers who are either required to join the new place of their posting without availing of the joining time, or by curtailing the same to the minimum and also those who, for any reasonable cause, prefer to avail of the same later, but within a period of three months from the date the charge is relinquished.
