TERMS AND CONDITIONS OF TENDER

- 1. The rate contract will be signed for a period of one year.
- 2. The firm will be liable to refill Fire Extinguisher Cylinders on fixed rates on their expiry.
- 3. The firm will provide fresh Fire Extinguisher Cylinders, ISI Mark as per need of the Academy on fixed rates.
- 4. The firm should intimate the rates <u>excluding VAT/TAXES</u> (as applicable) and <u>inclusive of Freight, Loading-Unloading charges, delivery or other charges</u> through the official email ID of the Academy or in hard form in sealed envelopes.
- 5. The Firm after successful re-filling of the Fire Extinguisher Cylinders will certify that the powder refilled is ISI Mark or as per instructions of the Government of India and also certify the filling percentage of powder.
- 6. The refilled Fire Extinguisher Cylinders should be valid for the period of 02 years and certificate in this regard shall be required from the Firm after every successful refill.
- 7. The firm should mention the period of time required by them after placing order for refilling and purchase of the requisite Fire Extinguisher Cylinders by this Academy.
- 8. The Academy reserves the right to get the services done from any other party at the cost of the firm, if services provided by the firm are not found satisfactory as per prescribed standard wholly or partly with prior intimation to the firm.
- 9. In case of non-providing of better services to the Academy, Academy shall reserves the right to terminate the rate contract or levy penalty on the 'Firm' as decided by Director (Admn.), Chandigarh Judicial Academy.
- 10. The 'Firm' shall be duty bound to render the services for which the contract will be allotted to the entire satisfaction of the Academy.
- 11. Company Engineer will visit for inspection in the Academy regarding requirement for refilling and purchase of Fire Extinguisher Cylinders.
- 12. If any information furnished by the applicant is found to be false at any stage, the application shall be cancelled and shall be liable to be debarred from tender.
- 13. The Company will provide rates of refilling and purchase including spare parts of Fire Extinguisher Cylinders.
- 14. Agency will take care of all equipments installed in the Academy during refilling, installation or any tamper.
- 15. All the jurisdictions will be at District and Sessions Court, Chandigarh.

MODE OF PAYMENT

- (i) The 'Academy' shall make payment on order basis subject to the satisfactory performance of services.
- (ii) The payment will be processed on order basis after due verification. Payment of each order will be released within 15 days of bill date through IDBI Bank, Sector 43, Chandigarh.
- (iii). Notwithstanding the expiry of the period of contract the 'Academy' may direct the 'Firm' to continue to provide the services in the Academy till alternative arrangements are made. It is hereby agreed to and expected that the 'Firm' would continue to provide the Services covered by this Agreement on receipt of written order from the Academy in spite of the expiry of the period of contract. If the 'Firm' fails to comply with the orders of the 'Academy' herein referred to above, it shall be liable to pay compensation/damages that may be assessed for making immediate and emergent arrangements for services in the Academy.
- (iv). The Chandigarh Judicial Academy reserves the right to accept or reject Tender/Rate Contract without providing any justification.
- (v) The contractor must put his signature with seal of organization on each page of the tender document.

Arbitration:

All disputes or differences, including the claims for damages and compensation whatsoever, arising between the parties, out of or relating to this agreement or the breach thereof shall be settled amicably. In case the dispute is not amicably settled then the dispute would be referred to Senior Most Additional District & Sessions Judge posted in the Academy.
