1. Size :- 4' (L) x 4' (W) x 8' (H)
2. Iron Frame :- 1½" X 1½" X 6 mm Angle
3. Door Size :- 2'x 6'
4. Body :- 12 mm thick water proof premium ply (BWP Marine Grade plywood IS:710)
5. Roof Covering sheet:- 12 mm thick water proof premium ply (BWP Marine Grade plywood IS:710) + 24 gauge aluminum sheet over the ply.
6. Sheet Covering the:- 24 gauge aluminum sheet (2' height) bottom  
Area of the post (Lower portion of the post to be covered with this sheet)
7. Sliding Glass :- 14' x 2' (Saint Gobain/Modiguard)
8. Flooring Sheet :- Steel chequered sheet (minimum 5 mm thickness). The sheet should be supported by two crossed iron angles underneath.
9. L-Drop Door Latch :- 1 no.  
from Outside
10. Latch from Inside:- 1 no.
11. Inner Shelf size:- 1½' x 4'
12. Legs:- 1 ft. (To be counted additional from 8' height)
13. Painting:- A-1 quality water based enamel paint (Green colour) on both inner and outer side.
